

ISCS Behaviour Addendum

At ISCS, we have adopted stringent precautionary measures and actions to reduce the possibility of transmission of infection among students and to provide a safe and healthy educational environment.

In light of the need for children to behave differently and to follow specific rules on their return to school during the Covid-19 epidemic, this amendment to the Behaviour Policy outlines specific changes to guidance that pupils will have to follow. Our sole guiding principle when making any changes or adjustments to policy is to be able to keep all of our children, families and staff safe and place their wellbeing at the forefront of everything we do.

The following behavioural guidelines have been added to the existing behaviour policy.

Behaviour Expectations:

- amended expectations about breaks or play times, including where children may or may not play
- rewards and sanction system where appropriate if changed from main body of policy

School Routines and Procedures:

- following any altered routines for arrival or departure
- following instructions on who pupils can socialise with at school – following the bubbles
- moving around the school as per specific instructions (for example, one-way systems, out of bounds areas, queuing, one person only in the toilets)
- rules about sharing any equipment or other items including drinking bottles
- use of toilets

Hygiene and Health Expectations:

- following school instructions on hygiene, such as hand washing and sanitizing.
- high expectations about sneezing, coughing, tissues disposal, avoiding touching mouth, nose and eyes with hands
- tell an adult if you are experiencing symptoms of coronavirus

If students display any behaviour that the school deems inappropriate they will be instantly sent home for a given time.

If a student intentionally or provocatively displays a behaviour that could put others in the school at risk from Covid-19 they will be instantly sent home for a given time.
